State of Maine **Special Mobile Equipment Registration Packet**

(Be sure that every item is checked off before sending us your paperwork.)

- Owner Info Sheet (Page 2)
 - A. (ONLY if this is your first time registering with us or your address has changed.)
- Notarized Power of Attorney (Page 3)
 - A. (ONLY if this is your first time registering with us.)
- Bill of Sale or Invoice / Proof of Ownership
 - A. If you have previously registered the trailer(s) in your state, we will need a COPY of a registration in your name.
 - B. If you have NOT registered your trailer before we will need a copy of your Bill of Sale (It must include the 17-digit VIN, year, make, sale price and be signed by the seller.) or Invoice
 - i. Maine does NOT charge sales tax on these types of trailers.
 - C. OR a copy of a Title that has been signed over to you or in your name.
 - i. Maine does NOT title Amusement, Concession, Food, Game or Special Equipment trailers.
- Payment (in the form of a money order or credit card)
 - A. Credit card form included in the packet (Page 5)

NOTE: Please contact us before you complete this form if you are trying to register a Homemade Trailer.

IMPORTANT NOTICE: *Although it is legal, in the State of Maine, to provide a valid Maine Plate and Registration to an out of state registrant, it may NOT be legal for you to register your trailer outside the state in which you reside. We would advise you to check with your local municipality or law enforcement to make sure that you are abiding by your current State Laws. If you choose to ignore your state laws, you do so at your own risk.*
