- i. There is No Sales Tax for trailers used for Interstate Commerce.
  - ii. Read below to see if you are required to title as well.

**☒** For trailers that are 3,001 lbs. or MORE UNLOADED weight and have NOT been titled in your name already, we would need you to send us the **Original Title** or **Certificate of Origin** that has been signed over to you, along with the bill of sale or invoice.

- A. Trailers that are 3,000 lbs. or less UNLOADED weight cannot be titled in Maine. If you wish to get a title in your name you will need to do so in your state. (Sales Tax in your state may apply.)
- B. If the Title is already in your name, we will just need a copy of it.

**NOTE: Please contact us before you complete this form if you are trying to register a Homemade Trailer. We also cannot register or title Salvage trailers.**
