C. OR a copy of a Title that has been signed over to you or in your name.

i. Maine does NOT title Amusement, Concession, Food, Game or Special Equipment trailers.

**NOTE: Please contact us before you complete this form if you are trying to register a Homemade Trailer. We also cannot register or title Salvage trailers.**

**IMPORTANT NOTICE:** *Although it is legal, in the State of Maine, to provide a valid Maine Plate and Registration to an out of state registrant, it may NOT be legal for you to register your trailer outside the state in which you reside. We would advise you to check with your local municipality or law enforcement to make sure that you are abiding by your current State Laws. If you choose to ignore your state laws, you do so at your own risk.*
