- B. IF you have <u>NOT</u> registered your trailer before, we will need a Copy of your Bill of Sale or Invoice. (Your Bill of Sale or Invoice must include the 17-digit VIN, year, make, sale price, and be signed by the seller over to you or your business.)
 - i. Maine's Sales Tax (5.5%) may apply, if not paid already.
 - ii. <u>Read below to see if you are REQUIRED to title as well.</u>

The Original Title or Certificate of Origin (ONLY IF...)

- 1. Your trailer is 25 years old or newer.
- 2. <u>AND</u> your trailer weighs 3,001 lbs. or MORE UNLOADED weight and has NOT been titled in your name previously.

If the Title is already in your name, we will just need a copy of it.

- Trailers that are 3,000 lbs. or less UNLOADED weight cannot be <u>titled</u> in Maine but can be registered here with just a Bill of Sale.
- If you wish to get a title in your name, we advise you to do a "Title ONLY" in your state and pay your sales tax BEFORE you register your trailer in Maine and provide us with a copy of the receipt.

NOTE: Please contact us before you complete this form if you are trying to register a Homemade Trailer. We also cannot register or title Salvage trailers.

If you choose to ignore your state laws, you do so at your own risk.

As of January 1st, 2017, we no longer register: Camper Trailers, Pop-Up Campers, RV's or <u>Bunkhouses.</u>
